### Fee Payment Information

1. Enrolment under \$1000 (Trainees only) – 1 payment, invoiced for full amount. Cheque, cash or Direct Debit collected before or on enrolment.

1. Enrolment under \$1000 - either 1 payment, or 50% non refundable deposit and up to 4 other payments via a Direct Debit form.

2. Enrolment over \$1000 (Trainees only) - If the employer is paying they may pay the whole amount, or an MOU can be created with first invoice 25% and 3 subsequent invoices in months 2, 3 and 4

2. Enrolment \$1000 to \$4000 - Non refundable 25% deposit up to 3 instalments in months 2,3 and 4, a Direct Debit form must be completed before enrolment.

3. Enrolment over \$4000 - Non refundable 10% deposit with negotiated instalments recorded on Direct Debit form prior to enrolment.

Files will not be processed if the Direct Debit form (where applicable) has not be fully completed.
